Aircraft Use Agreement

THIS AGREEMENT by and between USER, and Aspen Flying Club, Bay Area Flying Club, Western Air Flight Academy, and Aurora Flight Training, herein after referred to as "THE CLUB" or "CLUB", 13000 East Control Tower Road, Box K-16, Englewood, Colorado, 80112.

The USER is making an application to THE CLUB, and such application has been duly approved by THE CLUB. In consideration of the regular payment of dues and other charges billed to the USER and of the covenants, terms, and conditions of this agreement, it is mutually agreed that:

- 1. USER shall be entitled to engage in all of THE CLUB's flying activities and to use the aircraft in accordance with the rules and regulations provided.
- It is agreed by USER that he/she will indemnify, protect and hold harmless THE CLUB from all claims, demands, causes of actions, suits or costs whatsoever asserted by any person, firm or corporation arising from the operation of the aircraft by USER, specifically including, but not limited to, operation in violation of any United States Federal Aviation Regulations or THE CLUB's Policies and Procedures.
- 3. USER further agrees to pay THE CLUB dues in a timely manner each month commencing on the date below, and after each flight to pay for aircraft rental, maintenance, fuel, lubricants and other costs, as included in the latest CLUB Schedule of Equipment Rates, which is subject to change by THE CLUB from time to time upon notice to USER.
- 4. If the USER fails to pay any money due under or in connection with the Rental of Aircraft within 14 days of the date by which the Renter was required to pay the money, the Club may, without prejudice to any other rights or remedies the Club may have or be entitled to, charge the Renter and the Renter must pay all additional costs as outlined below:
 - a. interest at 10% (compounded daily) on the total amount owing from the expiry of 14 days from the date on which the hirer was required to pay the money to the date of payment;
 - b. all costs incurred by the owner for the collection of the unpaid money by a debt collection agency or other external or legal agency; and
 - c. an administration fee of \$50.
- 5. This agreement shall be binding upon the heirs, legal representatives, and successors of the parties hereto.
- 6. USER acknowledges that he/she has received a complete copy, read and fully understands the Policies and Procedures for THE CLUB aircraft usage and agrees to abide by the same in all respects.
- 7. USER hereby agrees to adhere to the United States Federal Aviation Regulations and to the Policies and Procedures for THE CLUB aircraft usage as they may be amended from time to time. The Policies and Procedures for THE CLUB aircraft usage are incorporated herein by reference as is fully set forth therein.
